PUBLIC POLICY COMMITTEE



The Public Policy Committee of AmCham Estonia is composed of leaders of its member companies that monitor policies and legislation which affect the interests of the business community and impact the economy and investment climate.

It is the aim of the committee to support policies that assist in the development of opportunities for job creation and business growth and oppose regulations that negatively affect business. In doing so, the committee will seek out issues that are not covered by any of the other issue-focused committees (Travel & Tourism, Healthcare, Digital Society, Talent & Education) and will consolidate member positions on those. They will include Taxation, Trade, Financial Services, General Business Diplomacy, Foreign Direct Investment, Energy, and other policy areas. To achieve its goals, the Committee will look for opportunities for a proactive approach, providing regular regulatory counsel to the government – in a permanent dialogue with period meetings, if possible.

The Committee will act as a first address for member companies, who have specific issues

or concerns about policy developments. The Committee, while not necessarily assuming a role in direct interest representation, will counsel the member company and refer them to a more professional framework of advocacy – be it an issue-specific committee or similar.

The Committee will strive to represent foreign investor perspectives and co-operate with other like-minded business interest representation organization to achieve impact.

KEY ADVOCACY AREAS AND TOPICS

Here are the key areas that our members, whose business operations span from Estonia to America and everywhere else, wish to highlight as those where we see most room for improvement and where we can partner the government in constructive dialogue:

Estonia should build on its position in the Digital Frontrunners (D9+) Group in the EU to guarantee that the Single Market of digital services will be developed on the principles of open economy, free trade and transatlantic co-operation, railing against the poisonous effects of protectionism. Estonia is a hotbed of technology startups and overzealous regulation will hamper its growth, restrict its ambitions and pull a blanket of administrative burden over it so thick that it will discourage many new innovators from taking the leap of faith.

We welcome the government's pledge to increase public sector R&D funding to 1% of GDP. It is clear – if the universities do not have the science programs needed to spur innovative thought, if there is no mechanism to transfer those ideas to industry, if there is no automation and digitization of the manufacturing space, then our joint dreams will remain only those.

We are supportive of the government's decision not to institute new taxes and to refrain from raising existing ones. In addition, we ask of you to fight the good fight also in the EU and OECD, helping build consensus around anti-discriminatory rules for the planned digital services tax. Additionally, in order to preserve the ability of the businesses to transfer personal data to the U.S., we ask all relevant authorities, at national and EU level, to urgently negotiate with the U.S. upon a new transfer mechanism to replace the invalidated "Privacy Shield".

We propose to the government that it continue to work towards a totalization agreement with the United States that would avoid dual taxation of wages. This would further attract talent and would enable workers from both countries to work between the nations and receive the benefit of social support without suffering from double taxation.

It is clear that the government's continuing enthusiasm of supporting Artificial Intelligence (AI) represents one of the biggest technological opportunities for innovation and productivity growth in Estonia - in the public and private sector. We support the proposals included in Estonia's national AI strategy for the period 2019-2021 and accompanying Report of Estonia's Al Taskforce (i.e. Kratt Report). It is important to refrain from "one size fits all" solutions in legislating AI as it would unnecessarily stifle development of the very diverse universe of potential applications. The proper approach is to take a sectoral and application-specific view of needed rules and regulation and engage the parties that will be in charge of developing them – the business community.

The Estonian healthcare system is one of the most efficient in the world, taking into account how under-financed it is. Lack of finance for actual treatment reduces GDP and quality of life. At the same time, there is potential beyond what is imagined today around digital health services. The attractiveness or even feasibility of the Estonian business environment is contingent on how well the health system functions, whether medicines and health services are accessible for all residents. We are willing to engage the government on continuing the work of building an eHealth system that allows for this to happen.

The plight facing the travel and tourism industry is beyond pale. It is in the short term, the most under-appreciated challenge in the Estonian economy and has received scant attention from policy makers. The value destruction that is taking place in this sector, where due to understandable restrictions there is no economic activity, is almost unprecedented in the modern times. In a sector where the lack of qualified staff was already a problem, this may further cause a devastating effect, lowering the

high standard of hospitality and service that people have come to expect from Estonia. Our Travel & Tourism Committee is willing to meet the the new government to provide a detailed overview of what can be done for the industry to stop it from collapsing.

The Estonian economy must again become vibrant and open. We welcome the decision to continue further developments in attracting international talent to Estonia. We look forward to working with the new government to make

sure the Estonian economy can be kickstarted immediately after the COVID-19 situation allows it.

AmCham Estonia calls upon a permanent dialogue between the foreign investor community and the Estonian government. This will give businesses the added predictability that comes with a better understanding of the government's plans and intentions, as well as an opportunity to voice ideas and proposals in the common interest.


